WORKING IN PARTNERSHIP WITH EL PASOANS FIGHTING HUNGER, ALONG WITH WEEKLY DONATIONS OF FRESH PRODUCE FROM QUALITY FRUIT WHOLESALE COMPANY, OVER 160 FAMILIES PER WEEK RECEIVED ESSENTIAL ITEMS AND NON-PERISHABLE FOODS. THROUGH THE YLM DRIVE-THRU FOOD PANTRY, AN AVERAGE OF 1,590 FAMILIES WERE SERVED THROUGHOUT THE YEAR.
